Dear Ms. Trowbridge and Mr. Miller:

On behalf of Harley-Davidson Motor Company, Inc. (Harley-Davidson), Groundwater Sciences Corporation (GSC) is forwarding this letter and the enclosed report regarding the Groundwater Human Health Risk Assessment (HHRA) for the former York Naval Ordnance Plant (fYNOP). The purpose of this letter is twofold as follows:

• Withdrawal of Previous Groundwater HHRA Submittal – This letter is a formal request to withdrawal the Groundwater HHRA and the accompanying Groundwater HHRA Executive Summary Reports dated August 25, 2016. These two documents were submitted previously to the Pennsylvania Department of Environmental Protection (PADEP) and the United States Environmental Protection Agency (USEPA) on September 12, 2016, and can be discarded or returned to GSC. Note that the two HHRA documents were submitted concurrent with the Supplemental Remedial Investigation Groundwater Report (Part 2) dated August 2016 (Part 2 SRI Report). This letter is not in any way intended to modify the submittal or review of the Part 2 SRI Report, which is scheduled for regulatory review by December 9, 2016.

• New Groundwater HHRA Submittal – Enclosed with this letter is a new Groundwater HHRA Report dated November 21, 2016. The new report is being submitted as a standalone document to replace the previously submitted HHRA documents, and was modified to address comments from the USEPA during our meeting on November 3, 2016. Based on email correspondence from PADEP dated November 14, 2016 to GSC and Harley-Davidson, it is understood that an additional report review fee and municipal/public notifications are not required with this new submittal.
