Dear Ms. Fisher:

This letter is in response to the Draft Supplemental Remedial Investigations Soil Report for the former York Naval Ordnance Plant, currently the Harley Davidson Motorcycle Company, prepared by Science Applications International Corporation and dated December 1, 2009. The report was prepared and submitted in accordance with the One Cleanup Program established by the United States Environmental Protection Agency (EPA) Region 3 and the Pennsylvania Department of Environmental Protection (PADEP).

EPA and PADEP have reviewed and hereby approve the Supplemental Remedial Investigations Soil Report in accordance with the provisions of the One Cleanup Program and the provisions of the Land Recycling and Environmental Remediation Standards Act (Act 2). This report was reviewed by or under the supervision of a Pennsylvania licensed professional geologist.

Please note the Uniform Environmental Covenants Act (Act 68 of 2007), Title 27, Pa.C.S. Chapter 65 (UECA), became effective on February 19, 2008. This law provides a standardized process for creating, documenting and assuring the enforceability of activity and use limitations on contaminated sites involving engineering and institutional controls used to achieve Act 2 standards. PADEP's approval of a Final Report may need to be supported by an environmental covenant. EPA and PADEP will need to approve such covenants before approval

of any Final Report. Two signed copies of the environmental covenant will need to be submitted with the Final Report, and then recorded on deeds of affected properties. Further information about UECA may be found on the PADEP's web site (www.dep.state.pa.us) under the program "Land Recycling."

Thank you for your cooperation in working with EPA and PADEP in the remediation of this site. We look forward to receipt of the Supplemental Remedial Investigations Groundwater Report and future cleanup efforts.
